Subscrisa, **ENERGO-PRO TRADING EAD** (detinand Licenta pentru furnizarea de energie electrica nr. 1598/05.02.2014), avand forma juridica de societate pe actiuni, avand Cod Fiscal BG201398872, cu sediul in Bulgaria, Sofia 1000, Districtul Sofia, municipiul Stolichna, regiunea Triaditza, Piata Pozitano nr. 2, etaj 5, reprezentata legal de Dna Yana Marinova Dimitrova,

The undersigned, **ENERGO-PRO TRADING EAD** (holding the License for electricity trading no. 1598/05.02.2014), joint stock company, having Fiscal Code BG201398872, with headquarters in Bulgaria, Sofia 1000, Sofia District, Stolichna municipality, Triaditza region, no. 2 Pozitano Square, 5th floor, duly represented by Mrs. Yana Marinova Dimitrova,

Avand in vedere:

- Dispozitiile art. 1 din Ordinul ANRE nr. 7/2017 pentru stabilirea regulilor privind publicarea informatiilor aferente tranzactiilor incheiate pe piata de energie electrica, potrivit caruia „Operatorii economici implicati in contracte incheiate pe piata reglementata sau de export sunt obligati sa transmita la operatorul pietei de energie electrica o copie a acestor contracte, in termen de maximum 7 zile de la data incheierii lor”;
- Faptul ca Energo-Pro Trading EAD a realizat tranzactii pe granita (nominalizare 1:1), in care co-contractantul este aceeasi entitate – Energo-Pro Trading EAD, iar aceste tranzactii, avand in vedere ca implica o schimbare in pozitia aceleasi entitati, nu pot fi concretizate intr-un contract;
- Faptul ca la data prezentei nu exista o interpretare oficiala a dispozitiilor Ordinului ANRE nr. 7/2017;

Whereas:

- The provisions of art. 1 of ANRE Order no. 7/2017 for establishment of the rules regarding the publication of the transactions concluded on the electricity market, according to which “The economic operators involved in contracts concluded on the regulated market or of export are obliged to transmit to the operator of electricity copies of such contracts, within a term of maximum 7 days as of their conclusion”;
- The fact that Energo-Pro Trading EAD performed transactions on border (1:1 nominated), where the counterparty is that same entity – Energo-Pro Trading EAD, and those transactions, taking into account that such involves a change in the position of the same entity, cannot be embodied in a contract;
- The fact that at this time there is no official interpretation of the provisions of ANRE Order no. 7/2017;


