Avand in vedere:

- Dispozitiile art. 1 Ordinul ANRE nr. 7/2017 pentru stabilirea regulilor privind publicarea informatiilor aferente tranzactiilor incheiate pe piata de energie electrica, potrivit caruia „*Operatorii economici implicati in contracte incheiate pe piata reglementata sau de export sunt obligati sa transmita la operatorul pietei de enegie electrica o copie a acestor contracte, in termen de maximum 7 zile de la data incheierii lor*”;
- Faptul ca PETROL d.d., Ljubljana a realizat tranzactii pe granite (nominalizare 1:1), in care co-contractantul este aceeaasi entitate – PETROL d.d., Ljubljana, iar aceste tranzactii, avand in vedere ca implica o schimbare in pozitia aceleiasi entitati, nu pot fi concretizate intr-un contract
- Faptul ca la data prezentei nu exista o interpretare oficiala a dispozitiilor Ordinului ANRE nr. 7/2017, privind tranzactiile cu nominalizare 1:1;

The undersigned, **PETROL, Slovenska energtska družba, d.d., Ljubljana** (*holding the Licence for electricity trading no. 2048 as of 29.09.2017*), having the legal form of joint stock company, registered with the Trade Registry and Judicial Registry of the Agency of the Republic Slovenia for Public Records and Services under no. 5025796000, VAT No. SI80267432, with its headquarters at Dunajska cesta 50, 1000 Ljubljana, Slovenia, tel. no. +386 (0) 1 4714 700, fax. no. +386 (0) 3201 894, **legally represented by Mr. Rok Vodnik**, in his capacity of Member of the Management Board (hereinafter referred to as **PETROL d.d., Ljubljana**)

Whereas:

- The provisions of art. 1 of ANRE Order no. 7/2017 for establishment of the rules regarding the publication of the transactions concluded on the electricity market, accrding to which „*The economic operators involved in contracts concluded on the regulated market or of export are obliged to transmit to the operator of electricity copies of such contracts, within a term of maximum 7 days as of their conclusion*”;
- The fact that Petrol performed transactions on border (1:1 nominated), where the counterparty is the same entity – PETROL d.d., Ljubljana, and these transactions, taking into account that this involves a change in the position of the same entitiy, cannot be embodied in a contract;
- The fact that as this time there is no official interpretation of the provisions of ANRE Order no. 7/2017, regarding the transactions 1:1 nominated;

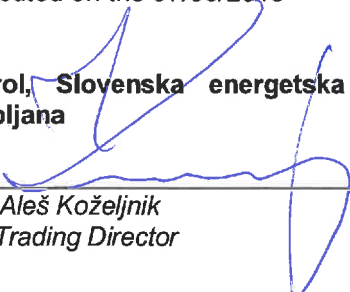
